SUPERINTENDANT REPORT

- Not much change in enrollment
 - Lost a couple of students
 - o Likely to pick up a couple over the winter break
 - o In packet enrollment is at 986
 - What grade levels that students are in is important
 - For teacher needs
 - So we are staffed appropriately
 - New office just got moved into
 - Well laid out
 - Lunch to celebrate
 - Seems very siloed before

- Now the team is closer together
- o Will be reaching out to the leaders (John Bergstrom/Miron) of the project to thank them
- St Margaret Mary is bidding out to redo the fob system
 - Software has obsolesced out
 - Would prefer to make all the fobs the same for the whole system
- Engaged with third party to assess technology
 - Started this week
 - Will be here for a couple weeks
 - Initial report is network is worse case practice
 - Not working correctly
 - Will report back as the assessment is complete
 - Many things to work on to get to the level we expect
 - Need to only have a level of technology to maintain the necessities of the school.

FINANCE COMMITTEE

- Try get some background information to prepare for approval of budget
- Dave Dietrich hired a new accounting manager
- According to Dave, working on a bottom-up budget, so there is ownership by all members
- Kristen has been helping Dave
- Committed to have a draft by next BOT
- Grounded on major consideration
 - Aspirational goal to get teachers to 80% of public-school teachers by 2026
 - Came from the Diocese

- o Need to increase salaries by 5% every year to 2026
- o Goal to get to 35 percent offertory giving by the Parishes
 - Reduction from giving and reduction of requirement
- Increase in choice school students
 - May have maxed out the use of Choice
- o About a \$320,000 increase in the bucket for salaries by 2026
- Losing about \$51,000 from Parishes
- Comparison with other private schools
 - Undervalued in the elementary schools
 - Pretty close with the middle and high schools
 - Numbers only for list price of school
 - Not including grants
- January meeting very financially driven
 - Need to see budget well before January BOT meeting
 - Keep up on info that bill sends out
 - Complete package to be sent out before the January meeting
 - Endorsed by the finance committee
 - Cost per student around \$10,000/student
 - System average
 - Tuition well below costs
 - Maxes for students is around 100/grade in elementary and 75/grade in mid and high school
 - Planning to have the problem to be too many students
 - Lots of financial work to do by January
