MIDDLE SCHOOL LEADERSHIP WORK

- From Jill Ahles middle school principal
 - o Been at the middle school for 6 years
 - Need students to be leaders
 - Need to teach them to be leaders
 - Infusing leadership

- Feeling in the middle school that the changes are positive and affective
- Presenting the CharacterStrong program
 - CharacterStrong provides research-based Pre-K through 12th grade social & emotional learning curricula and professional learning services that positively impact lives.
 - Lead by:
 - o Mr. Brown; retired principal
 - Mr. Bogey; younger math teacher
 - Right two people to lead this
 - There is a donor for this program
 - Sponsorship initial investment covered, maintenance fee to be covered by the school
 - Work with students for 30 days for social/emotional lessons
 - Three prongs
 - o Improve Engagement
 - o Increase Belonging
 - o Promote Well Being
 - Requires a culture shift
 - Requires 7 graders to take a leadership class
 - o Building leadership
 - Community leadership with 8th graders
 - Morning leadership group
 - Charity before the day starts
 - 30 40 students at 7 am
 - Local leaders come in and present
 - o 6th, 7th and 8th graders are invited
 - Usually, full
 - Officers selected and apply what they learn
 - o 11 officers in the group of 7th and 8th graders
 - Appears to be more courtesies throughout the whole middle school
 - Noted by one person that the middle school is kinder

UPDATED METRICS ON STRATEGIC PLAN

- Update on modified budget ending Sept 30th
- Headline we are tracking toward the modified budget
- School choice increase was a big help
 - Huge gift to bridge gap
 - o As long as we hit budget, we will be good
- Targeting faculty 80 percent wages and benefits
 - o Currently underbudget for wages
 - We budgeted on wages to bridge gap between public and private schools
 - We try to reflect budgets that includes turnover and increase in replacement positions
 - o Need to review and adjust budget better
 - Do we need to account for a travel budget?
- Only one student down from modified budget
- Finance committee met in October and will look at a 5-year plan to bridge budget deficits
- Try to hit milestones for Momentum, this is a must do
- Approximately \$309,000 from Shippeck estate, closed out now
 - Approximately \$75,000 added to the foundation
