- Enrollment at about 980
  - About 5 or 6 foreign exchange students
  - o Current enrollment status is trending toward meeting our budget
  - Enrollment numbers are good
  - Working to get better at reporting student numbers
- Hiring numbers going well also
  - Counseling positions available
  - 5 teaching positions available, but looking good
    - More people in place

- Very good teachers
- Big difference from last year
- Dave Dietrick (Director of Business Services) here last week for Executive Committee meeting
  - Kristin Bergstrom is still helping and getting Dave up to speed
  - Working on getting finances organized
  - o Doing well
  - Pleasant person
- Dan spoke to Phil on technology spending
  - SMCS may be pulling back on technology
  - What should we look like in 5 10 years
  - o Looking to put a plan in place, instead of current owners' direction
  - o A committee has been put together to come up with a plan
  - o Part of the technology plan will be to update the school's doors
  - o Phone system does not work as well either and may be part of the update
  - School should be providing for the parishes as well
  - o Parishes should get better technology from us
  - o Need to be part of one plan, instead of discussed separately
- Superintendent name should be changed back to President
  - 'President' name works better for a campus that is private and with multiple campus's
